Dear Brad:

Thank you for choosing the Santa Barbara Harbor as a destination for your cruise. To confirm your reservations for 07/14/14 thru noon 07/20/14 the following requirements must be met:

1. Berthing will only be reserved for the day or days, designated by the Cruise Chairperson and **paid for in advance**. Our visitor berthing rate is \$90 per foot per day, for the first 14 days. After 14 days, berthing rates increase to \$1.80 per foot. Maximum stay in the harbor is 28 days.
2. Credit card payment required (Visa, Master Card, Discover). Call by phone with the credit card number, expiration date and authorization for the Santa Barbara Waterfront and Harbor Patrol office to charge the card. We do not hold credit card numbers on file here.
3. A blue visitor slip permit card must be completed. The information on the permit card includes the owner and/or operators name(s) and contact information, vessel registration numbers, vessel description and the vessel **overall** length and beam measurements, (include pulpits, swim steps, etc.). This information can be provided to us over the phone or returned to us via email or mail. Upon your arrival to Santa Barbara the card will need to be signed by you and we will need to see the vessel's registration or documentation.
4. Key cards for the marina gates and showers are available at the Harbor Patrol Office for \$7.00 each. They can be purchased upon arrival. It is a onetime non-refundable purchase.
5. A cancellation fee equal to one day's visitor fee will be charged if a reservation is canceled within forty-eight (48) hours of the first day of the reservation.
5. The vessel will undergo a Marine Sanitation Device (MSD) inspection and dye tabbing upon vessel's arrival. Vessel and/or crew convicted of sewage discharge in the S.B. Harbor will be banned from the S.B. Harbor for one year and issued a citation.

**Harbor Visitor Slip Permit Release of Liability and Indemnification**

Visitor Slip Permittee, on behalf of him or herself and his or her heirs, executors and administrators and invitees, shall investigate, defend, indemnify and hold the City and the respective officers, agents and employees of the City harmless from and against all liabilities, obligations, damages, penalties, claims, costs, charges and expenses (including reasonable attorneys' fees) by reason of injury or death of any person, or damage to or destruction of any property which may be imposed upon, incurred by or asserted against the City, or the respective officers, agents and employees of the City arising out of or in any way connected with the Visitor Slip Permit or the use or enjoyment of the Santa Barbara Harbor by the Visitor Slip Permittee or invitees of the Permittee.

Visitor Slip Permittee hereby releases, waives, discharges and covenants not to sue the City of Santa Barbara, its employees, officers, and agents (hereinafter referred to as "releasees") from all liability to Visitor Slip Permittee, his or her personal representatives, assigns, heirs, next of kin and invitees for any loss, damage, or claim therefore on account of injury to the person or property of Visitor Slip Permittee or Visitor Slip Permittee's invitees, whether caused by any negligent act or omission of the releasees or otherwise while the Visitor Slip Permittee or invitees of the Visitor Slip Permittee is engaged in any way with the use or enjoyment of the Santa Barbara Harbor District.

Visitor Slip Permittee acknowledges that other than the issuance of a Visitor Slip Permit to Visitor Slip Permittee for Visitor Slip Permittee's use of the Harbor pursuant to the permit, no representation of fact or opinion has been made by the City of Santa Barbara or any of its respective officers, employees or agents, to induce this release, and that Visitor Slip Permittee has signed this release freely and voluntarily, after having read it completely, and with full knowledge of any rights or privileges that Visitor Slip Permittee may be waiving or releasing.
